**5 FEB, 5 MAR, 2 APR, 7 MAY, 3-5 JUN, 2 JUL, 6 AUG, 3 SEP, 1 OCT, 5 NOV, 3 DEC**

**RANGE LOCATION:** 12465 N.E. 234th, Arcadia, OK. Three miles north of Arcadia, OK, on Anderson Rd. At the corner of Anderson Rd. and Sorghum Mill Rd., turn east and proceed the gate and take a left on the range road.

**REGISTRATION:** All 2022 matches will be entered into PractiScore.com - early registration is encouraged and appreciated. The morning of the match, registration will be in the Gary Stephens High Power Rifle Club House beginning at 8:00 AM and will end at 8:30 AM. Competitors registering through PractiScore must check in at the club house prior to 8:30. Shooting will begin at 9:00 AM.

**RULES:** Current CMP rules will govern. It is the competitor's responsibility to be familiar with CMP rules and this program.

Note: 5 FEB and 3 DEC matches will be club matches rather than CMP sanctioned matches

**CATEGORIES:**

For matches 1-4, categories will be Service Rifle, PALMA Rifle, Match Rifle, Match Rifle with Optics, and AR-Tactical. If fewer than three entries are in a category/classification, they may be combined as appropriate.

For matches 5-8, categories will be F-T/R, and F-Open. If fewer than three entries are in a category/classification, they will be combined. These categories will compete for aggregate awards and individual matches.

**ENTRIES:** Open to any individual. If you are a CMP competitor, it is necessary to furnish your CMP competitor number to enter. It is easy to obtain one through the CMP. An Eligibility Affidavit is required per CMP Rule 2.2 and will be available at registration.

**MATCH SCHEDULE:** Match begins @ 9:00AM

Match#1: 600 YD SF, Target MR-1, Prone, unlimited sighting shots, 20 shots for record, 25 minutes.

Match#2: 600 YD SF, Target MR-1, Prone, 2 sighting shots, 20 shots for record, 22 minutes.

Match#3: 600 YD SF, Target MR-1, Prone, 2 sighting shots, 20 shots for record, 22 minutes.

Match#4: Aggregate of Matches #1-#3.

Match#5: 600 YD SF, Target MR-1-F, Prone, unlimited sighting shots, 20 shots for record, 25 minutes.

Match#6: 600 YD SF, Target MR-1-F, Prone, 2 sighting shots, 20 shots for record, 22 minutes.

Match#7: 600 YD SF, Target MR-1-F, Prone, 2 sighting shots, 20 shots for record, 22 minutes.

Match#8: Aggregate of Matches #5-#7.

Matches 1 and 5, 2 and 6, 3 and 7 will be fired concurrently.

**COMPETITOR RESPONSIBILITIES:** Competitors will be required to perform score keeping duties and operate targets if the ShotMarker scoring system is not operational or is available. All matches are currently planned to use the ShotMarker scoring system; please bring a WIFI capable device for scoring and or individual use.

**AWARDS:** Awards will be cash prizes. Classes and or categories will be combined if less than three (3) entries. First and Second Place Aggregate and Individual match winners will be awarded. Second place class awards in the aggregate if eight (8) entries. Third place class awards in the aggregate if thirteen (13) entries. The awards system will be altered at times to accommodate the specific aspect of the monthly match and at the discretion of the match director.
