

**THE OKLAHOMA CITY GUN CLUB
2024 NRA 3x600 MID-RANGE PRONE
AND 3x1000 LONG RANGE PRONE
F-CLASS V² QUALIFIER
HIGH POWER MATCH**

20 – 21 APRIL

RANGE LOCATION: 12465 N.E. 234th, Arcadia, OK. Three miles north of Arcadia, OK, on Anderson Rd. At the corner of Anderson Rd. and Sorghum Mill Rd., turn east and proceed approximately 1/2 mile. Go through the gate and take a left at the “T” on the range road, following it to the High Power Range.

REGISTRATION: Pre-Registration is encouraged and appreciated. The days of the matches, registration will be in the Gary Stephens High Power Rifle Club House beginning at 7:30 AM and will end at 8:30. Shooting will begin at 9:00 AM. Range capacity is limited.

RULES: Current NRA rules will govern. It is the competitor’s responsibility to be familiar with NRA rules and this program.

ShotMarker Settings: The electronic target system will be set for a seven second delay, with grid off and will only show recent shots. Shots fired during the 7 second delay will be scored as a miss. (NRA Rule 9.25.1)

CATEGORIES:

For matches 1-4, 9-12, 20-22 and 26-28, categories will be Service Rifle, PALMA Rifle, Match Rifle, Match Rifle with Optics, and AR-Tactical. If fewer than three entries are in a category/classification, they may be combined as appropriate.

For matches 5-8, 13-16, 23-25 and 29-31, categories will be F-T/R, and F-Open. If fewer than three entries are in a category/classification, they may be combined as appropriate.

SPECIAL NOTE: The 600- and 1000-yard matches will be fired concurrently. Competitors may enter either the 600-yard or the 1000-yard matches, but **NOT** both. Since this match is also an F-class V² Qualifier, **priority will be given to 1000-yard F-Class entries.** For those interested, on Friday the 19th prior to this match, there will be a 1000-yard Double elimination match and practice. See the Club Double Elimination match program for details.

ENTRIES: Open to any individual. If you have an NRA classification, it is necessary to furnish your classification card to enter. NRA members must furnish NRA Number to enter.

Match # 26: 1000 YD SF, Target LR, Prone, unlimited sighting shots, 20 shots for record, 30 minutes.

Match # 27: 1000 YD SF, Target LR, Prone, 2 sighting shots, 20 shots for record, 30 minutes.

Match # 28: Aggregate of Matches # 26 & 27.

Match # 29: 1000 YD SF, Target LR-FC, Prone, unlimited sighting shots, 20 shots for record, 30 minutes.

Match # 30: 1000 YD SF, Target LR-FC, Prone, 2 sighting shots, 20 shots for record, 30 minutes.

Match # 31: Aggregate of Matches # 29 & 30.

Matches will be fired concurrently as appropriate.

Match # 32 – Position Champion – 600-yards - Aggregate of Matches #4 and #22

Match # 33 – Position Champion – 1000-yards – Aggregate of Matches #12 and #28

Match #34 – F- Class Champion – 600-Yards – Aggregate of Matches #8 and #25

Match #35 – F-Class Champion – 1000-Yards – Aggregate of Matches #16 and #31

COMPETITOR RESPONSIBILITIES: Competitors will be required to perform score keeping duties and operate targets if the ShotMarker scoring system is not operational or is unavailable. All matches are currently planned to use the ShotMarker scoring system; please bring a WIFI capable device for scoring and or individual use.

We will **NOT** be presenting awards this year so that we can offset some of the cost of the 1000-yard range expansion. Thank you for your support and congratulations in advance to all the match winners.
