**RANGE LOCATION**: 12465 N.E. 234th, Arcadia, OK. Three miles north of Arcadia, OK, on Anderson Rd. At the corner of Anderson Rd. and Sorghum Mill Rd., turn east and proceed roughly half a mile where you can enter the gate on the north side of the road. Proceed through the gate and take a left on the range road.

**REGISTRATION**: Registration will be in the Gary Stephens High Power Rifle Club House beginning at 8:00 AM and will end at 8:30 AM. Shooting will begin at 9:00 AM.

**RULES**: Current NRA rules will govern. It is the competitor's responsibility to be familiar with NRA rules and this program. Please become familiar with the following NRA Rules: https://competitions.nra.org.

#### **CATEGORIES:**

A: Any Rifle P: Palma Rifle F-Class: O: F-Open T: F-TR

**NOTE:** All competitors shooting Any Rifle category will be grouped together for the entire match. They will be ineligible for the overall aggregate but will receive appropriate recognition based on entries.

**TARGETS:** Sling will use the LR target and F-Class will use the LR-FC target.

**ENTRIES**: Open to any individual. If you are an NRA member, it is necessary to furnish your NRA membership number to enter. The 23 June match will also be day 2 of an F-Class V<sup>2</sup> qualifier match. Rage capacity is limited so pre-registration to the V<sup>2</sup> qualifier is encouraged.

**FEES**: Entry fees: \$30.00; Juniors: \$15.00.

MATCH SCHEDULE: Match begins @ 9:00AM

#### **COURSE OF FIRE:**

Match #1: The Palma Match

Stage 1: 800 Yards prone slow fire. Unlimited sighters & 15 shots for record in 22 minutes.

Stage 2: 900 Yards prone slow fire. Two (2) sighters & 15 shots for record in 22 minutes.

Stage 3: 1000 Yards prone slow fire. Two (2) sighters & 15 shots for record in 22 minutes.

**COMPETITOR DUTIES**: Competitors will be required to perform score keeping duties and operate targets if the ShotMarker scoring system is not operational or is unavailable. Competitors are responsible for bringing an electronic device for interfacing with the ShotMarker system. All matches are currently planned to use the Shot Marker scoring system.

#### AWARDS:

We will NOT be presenting awards this year so that we can offset some of the cost of the 1000-yard range expansion. Thank you for your support and congratulations in advance to all the match winners.
