**CMP Approved High Power - MR/LR – Pair Fire
3x600 MID-RANGE PRONE or 3x1000 LONG RANGE PRONE**

RANGE LOCATION: 12465 N.E. 234th, Arcadia, OK. Three miles north of Arcadia, OK, on Anderson Rd. At the corner of Anderson Rd. and Sorghum Mill Rd., turn east and proceed approximately 1/2 mile. Go through the gate and take a left at the “T” on the range road, following it to the High-Power Range.

REGISTRATION: Registration will primarily be through Target Score (<https://targetscore.com>) but may also be accomplished through the mail with the registration form found at the end of this program. The OKCGC High Power web page has a target score sign-up instruction sheet at Target Score. Registrations must be received the Thursday before the match or may incur a \$5 late fee.

Competitors not registered through Target Score must notify the match director ahead of time to ensure squadding and be present when check-in begins for registration. You may be signed up for Target Score at that time which requires that you have a handheld device accessible email account.

Check-in will be at the Gary Stephens High Power Rifle Club House beginning at 8AM, ending at 8:30. All competitors must check in at the HP clubhouse.

Shooting will begin at 9:00.

RULES: Current CMP rules will govern. It is the competitor's responsibility to be familiar with CMP rules and this program.

Please become familiar with the following CMP High Power Rifle Rules but look for 2026 changes:

ENTRIES: Open to any individual. If you are a CMP competitor, it is necessary to furnish your CMP member number to enter. Entries for the 600-yard matches are limited to 16. Entries for the 1000-yard matches are limited to 48.

CATEGORIES: For matches 1-4 and 9-11, categories will be Service Rifle, PALMA Rifle, Match Rifle, Match Rifle with Optics, and AR-Tactical. If fewer than three entries are in a category/classification, they may be combined as appropriate.

For matches 5-8 and 13-16, categories will be F-T/R, and F-Open. If fewer than three entries are in a category/classification, they **may** be combined as appropriate.

SPECIAL NOTES: The 600- and 1000-yard matches will be fired concurrently. Competitors may enter **either** the 600-yard or the 1000-yard matches, but **NOT** both. This match will be shot pair fired. Pair firing - two competitors on the firing point with a time allowance of 45 seconds per shot per shooter.

ELECTRONIC TARGETS: The “Shotmarker” electronic target system will be used, you must bring a WIFI-capable device for scoring and individual use. There will be a 7 second delay, the grid will be off, and you will only see your recent shot.

COMPETITOR RESPONSIBILITIES: Competitors will be required to perform score keeping duties and operate targets (600 yards only) if the ShotMarker scoring system is not operational or is unavailable.

AWARDS: Medals will be provided for Sling, F-T/R and F-Open category winners.

FEES: Entry fees: Adults \$25.00 / Juniors: \$10.00

PRE-REGISTRATION: Pre-registration is **highly encouraged**; the form is below on page 3. There is no guarantee of space available for walk-ups.
