**2026 NRA INTERNATIONAL**  
**FULLBORE PRONE HIGHPOWER MATCHES**

**October 18**

**RANGE LOCATION:** 12465 N.E. 234th, Arcadia, OK. Three miles north of Arcadia, OK, on Anderson Rd. At the corner of Anderson Rd. and Sorghum Mill Rd., turn east and proceed roughly half a mile where you can enter the gate on the north side of the road. Proceed through the gate and take a left on the range road.

**REGISTRATION:** Registration will primarily be through Target Score (<https://targetscore.com>) but may also be accomplished the day of competition at the Gary Stephens High Power Rifle Club House. The OKCGC High Power web page has a target score sign-up instruction sheet at Target Score.

Competitors not registered through Target Score must notify the match director ahead of time to ensure squadding and be present when check-in begins for registration. You may be signed up for Target Score at that time which requires that you have a handheld device accessible email account.

Check-in will be at the Gary Stephens High Power Rifle Club House beginning at 8AM, ending at 8:30. All competitors must check in at the HP clubhouse.

Shooting will begin at 9:00 AM.

**RULES:** Current NRA rules will govern. It is the competitor's responsibility to be familiar with NRA rules and this program. Please become familiar with the following NRA International Full Bore Rules: <https://competitions.nra.org/competition-resources/rule-books/>

All matches will be pair firing (two to a mound) 2 convertible sighting shots and 10 shots for record at the 300-, 600- and 900-yard lines, and 15 shots for record at the 1000-yard line. Relays 1 and 3 will shoot on the right. Relays 2 and 4 will shoot on the left. The time limit of 45 seconds per shot will be observed at all distances (Rule 8.2.2). Competitors will score for each other during each match. There will be a blow off period prior to the first string of fire.

Matches 1-5, the categories will be Service Rifle, PALMA Rifle.

For matches 6-10, the categories will be F-T/R, and F-Open.

Matches 1 and 6, 2 and 7, 3 and 8, 4 and 9 will be fired concurrently.

**ENTRIES:** Open to any individual. If you are an NRA member, it is necessary to furnish your NRA membership number to enter.

**FEES:** Entry fees: \$30.00; Juniors: \$15.00. NRA Fee Included.  
Challenge fee: \$5.00

**MATCH SCHEDULE:** Match begins @ 9:00AM

**COURSE OF FIRE:**

Match # 1: 300 YD SF, Target MR-63, Prone, 2 sighting shots convertible, 10 shots for record.

Match # 2: 600 YD SF, Target MR-1, Prone, 2 sighting shots convertible, 10 shots for record.

Match # 3: 900 YD SF, Target LR, Prone, 2 sighting shots convertible, 10 shots for record.

Match # 4: 1000 YD SF, Target LR, Prone, 2 sighting shots convertible, 15 shots for record.

Match # 5: Aggregate of Matches #1-#4.

Match # 6: 300 YD SF, Target MR-63-F, Prone, 2 sighting shots convertible, 10 shots for record.

Match # 7: 600 YD SF, Target MR-1-F, Prone, 2 sighting shots convertible, 10 shots for record.

Match # 8: 900 YD SF, Target LR-F, Prone, 2 sighting shots convertible, 10 shots for record.

Match # 9: 1000 YD SF, Target LR-F, Prone, 2 sighting shots convertible, 15 shots for record.

Match # 10: Aggregate of Matches #6-#9.

**COMPETITOR DUTIES:** Competitors will be asked to assist in setting up the range prior to firing and securing the range when firing is complete. Competitors are responsible for bringing an electronic device for interfacing with the ShotMarker system.

**AWARDS:** A medallion or other appropriate award will be presented to the match winner and second place if sufficient entries.
