RANGE LOCATION: 12465 N.E. 234th, Arcadia, OK. Three miles north of Arcadia, OK, on Anderson Rd. At the corner of Anderson Rd. and Sorghum Mill Rd., turn east and proceed approximately 1/2 mile. Go through the gate and take a left at the "T" on the range road, following it to the High-Power Range.

REGISTRATION: Registration will primarily be through Target Score (<https://targetscore.com>) but may also be accomplished through the mail with the registration form found at the end of this program. The OKCGC High Power web page has a target score sign-up instruction sheet at Target Score.

Competitors not registered through Target Score must notify the match director ahead of time to ensure squadding and be present when check-in begins for registration. You may be signed up for Target Score at that time which requires that you have a handheld device accessible email account.

Check-in will be in the Gary Stephens High Power Rifle Club House beginning at 12:00 PM on 17 April, ending at 12:30. Shooting will begin at ~ 1:00 PM.

Check-in will begin at 8:00 AM on 18 and 19 April and will end at 8:30 both days. Shooting will begin at ~ 9:00 AM both days.

All competitors must check in daily at the HP clubhouse.

RULES: Current NRA rules will apply. This is an NRA Registered Match. It is the competitor's responsibility to be familiar with NRA rules and this program.

ENTRIES: The 600-yard team match will be limited to 8 teams. The 600-yard individual match will be limited to 16 entries. The 1000-yard team match will be limited to 24 teams. The 1000-yard individual match will be limited to 48 entries. Open to any individual. If you are an NRA competitor, it is necessary to furnish your NRA member number to enter. The entry deadline is 27 March 2026. Entries received after 27 March (including walk-ups) will incur a \$20 late fee, if space is still available. Early registration is highly recommended. Registration fees will be returned in case of complete match cancellation.

CATEGORIES:

For team matches 1, 2, 7 and 8, categories will be Service Rifle, PALMA Rifle, Match Rifle, Match Rifle with Optics, and AR-Tactical. If fewer than three entries are in a category/classification, they may be combined as appropriate.

For team matches 4, 5, 10, and 11 categories will be per the most current F-Class rule book. If fewer than three entries are in a category/classification, they **may** be combined as appropriate.

For individual matches 1-3, 9-11, 17-18 and 25-26 categories will be Service Rifle, PALMA Rifle, Match Rifle, Match Rifle with Optics, and AR-Tactical. If fewer than three entries are in a category/classification, they may be combined as appropriate.

For individual matches 5-7, 13-15, 21-22, and 29-30 categories will be per the most current F-Class rule book. If fewer than three entries are in a category/classification, they **may** be combined as appropriate.

SPECIAL NOTES: The 600- and 1000-yard matches will be fired concurrently. Competitors may enter **either** the 600-yard or the 1000-yard matches, but **NOT** both. * **V2:** 100-point Agg scores will qualify for V2 points as long as we have the min number of V2 Points Series Participants.

ELECTRONIC TARGETS: The “Shotmarker” electronic target system will be used, you must bring a WIFI-capable device for scoring and individual use. There will be a 7 second delay, the grid will be off, and you will only see your recent shot.

COMPETITOR RESPONSIBILITIES: Competitors will be required to perform score keeping duties and operate targets (600 yards only) if the ShotMarker scoring system is not operational or is unavailable.

AWARDS: Medals will be provided for Sling, F-T/R and F-Open category winners.

ENTRY FEES: 2-man team - \$50 per team – (Do not prepay team fees)
2-day individual - \$80 – Juniors \$40.00
Friday practice - \$10 – Juniors free
