## AR Steel Challenge

Decent weather conditions over June 21 weekend brought out several shooters AR Steel Challenge match. In the open sight division, Woody Liddell shot an incredible 19x20 using peep sights on his .223, to set a new open sight short course record! In the scope division, Dan Baily shot a perfect 20x20 score on the short course, followed by another perfect 20x20 score from Jim Fields, to set up a long range 500 meter shoot off. At 500 meters, Jim's 6.5 Grendel barely edged out Dan's .223 Les Baer with +2 hits to Dan's +1. Jim Fields then shot the long range course with his trusty 6.5 Grendel with a respectable 18x20. Mike Elston won the rapid fire contest with a super fast score of 19x20 in 50 seconds, over Dan Baily who also had a 19x20 but in 53 seconds. Total scores over the three courses of fire placed Dan Baily in the lead for overall three gun match win with a score of 55x60. For the 2014 season overall, Mike Elston has a commanding lead with 193 hits over the number two spot showing a 185.

The AR Steel Challenge match is held the last Saturday of the month (unless there is a conflict) from March through September on the silhouette range. The competition is open to the public so everyone is welcome. \$20 gets three entry cards for short, long and rapid fire AR competition with 20 rounds shot at each course. Any caliber AR rifle is acceptable with any sights. Practice sighters and safety briefing starts at 9am. New shooters are always welcome, so bring plenty of ammo.

The next AR Steel Challenge match will be on Aug 30, we will see you then!

**Changes in Match Directors:** Tony Wall will be taking over the monthly Steel Challenge matches. Mike Cyrwus will be taking over the 3-Gun matches. Chris Gober and Kurt Miller are pretty booked with those "other distractions" known as work life. I want to thank them for their long-standing support and also thank Tony and Mike for stepping up to keep our sport alive and well at the OKC Gun Club. It's a volunteer program and good matches only happen because folks are willing to step up! Remember to say thanks to them when you come to play.

**Scoring:** We had a problem with the scores on one stage this month and ended up having to throw the stage out. Unfortunately it was the classifier. Practiscore is a great piece of software but, after-the-fact, whatever was entered is the ONLY record we have to go by. The good news is that the scorekeeper in the stat shack can't induce an error typing in 700 scoresheets.... the bad news is that every person running the stage scoring can potentially make a mistake.... It is important to CHECK THE RESULTS AT THE TIME YOU SHOOT THE STAGE. Mistakes can be caught and corrected easily on the spot. Both the scorekeeper and the shooter should review the results before moving on to the next shooter. Our next IPSC match will be August 2nd.
