REMINDER: We had one unfortunate problem that was only discovered after the match was over, which resulted in having to zero one shooter's stage score. As the stage run was entered in Practiscore, an impossible time was entered by mistake. Nobody reviewed the results before accepting what was displayed and it wasn't noticed until that night. There is no paper backup to refer to and "making up a number hours after the match" isn't in the rulebook. We did not have a valid time, and the rules require a zero score in cases where a reshoot is not possible. Practiscore has many benefits to us, but this instance highlights the importance and **responsibility on the score-keeper and the shooter to make sure the summary results of a stage run are accurate BEFORE the results are saved** and everyone moves on to the next shooter.

In response to several requests, a number of target stands are staged in the north bays for use by club members. Please **KEEP THEM UP AT THE NORTH END**, and clean up after yourself. It might be a good idea to "BYOS" – Bring Your Own Sticks – for the stands; while we leave some out there, they seem to wander around the range and get shot up.

Our next monthly IPSC match will be January 3rd.... the start of a whole new shooting year. Many thanks to all of you who come to our matches and to the many people who pitch in and make it all possible. 2014 has been an awesome year for the Division, and it's thanks to all of you!!!
